**ABERDEEN INCOME CREDIT STRATEGIES FUND ANNOUNCES  
ISSUANCE OF SHARES AFTER COMPLETION OF RIGHTS OFFERING**

(Philadelphia, June 23, 2021) – [Aberdeen Income Credit Strategies Fund \(NYSE: ACP\)](#) (the “Fund”), a closed-end fund, announced today, in furtherance to its press release dated June 17, 2021, the issuance of shares in connection with the successful completion of its transferable rights offering (the “Offer”). The Offer commenced on May 20, 2021 and expired on June 16, 2021 (the “Expiration Date”).

The Offer entitled rights holders to subscribe for up to an aggregate of 5,812,247 of the Fund’s common shares of beneficial interest, par value \$0.001 per share (“Common Shares”). The final subscription price was \$10.20 per Common Share and was determined based upon a formula equal to 92.5% of the average of the last reported sales price of a Common Share on the New York Stock Exchange (“NYSE”) on the Expiration Date and each of the four (4) preceding trading days.

As a result of high investor demand, the Offer was over-subscribed. Accordingly, the shares issued pursuant to the over-subscription privilege of the Offer were allocated pro rata among those fully exercising record date shareholders who over-subscribed based on the number of rights originally issued to them by the Fund. The Fund issued all of the 5,812,247 Common Shares offered pursuant to the Offer, with a majority of those Common Shares issued pursuant to the primary subscription and the remaining Common Shares issued pursuant to the over-subscription privilege. The gross proceeds of the Offer were \$60 million. The Common Shares subscribed for were issued today.
